

HOW TO SUBMIT YOUR WELL PUMPAGE (ANNUAL REPORT) ONLINE

Before you start, make sure to have the following information:

- ✓ Permitting portal username and password
- ✓ Lead well number and physical location of well
- ✓ Number of wells in permit
 - If you have more than one well to report on, you will need to submit one form per well in your system. If you would like to submit a spreadsheet instead of multiple form submissions, please contact <u>info@subsidence.org</u> with AGGREGATE AGR in the subject line.
- ✓ Total system pumpage in gallons
- Individual well pumpage in gallons
- Visit <u>hgsubsidence.org/portal</u> on your web browser to access the online portal and log in using the email address associated with last year's well application.



• Click on Create Application located at the very top of the page.



• Select Well Pumpage (Annual Report) from the applications menu to file an annual report.

1. MAIN PANEL

The main section includes the lead well number and physical location of the lead well.

- If the well has been permitted previously, enter the well number. *NOTE: If you have multiple wells, the lead well number will be the lowest numerical well number.*
- Confirm the well number and physical location of the well are correct. *NOTE: If you cannot enter an accurate physical location of the well, leave it blank.*

- Enter the **Calendar Year** provided: (i.e., 1/1/2022)
- Input the Number of Wells in Aggregate, which is the total number of wells in the permit.
- Input the **Reporting Well** number you are submitting pumpage data for.
- Input the Total System Pumpage, which is the total groundwater (in gallons) pumped for all of your wells. Monthly groundwater withdrawals can be reported in subsequent fields. NOTE: Annual reports need to be completed for each well in an aggregate system. If you have more than one well to report on, you will need to submit one form per well in your system. If you would like to submit a spreadsheet instead of multiple form submissions, please contact info@subsidence.org with AGGREGATE AGR in the subject line
- Input the **Well Pumpage** in gallons for the well you are reporting. *NOTE: If you only have one well, this field will be the same as the total system pumpage.*
